2. The Compliance with the applicable provisions of the Companies Act, 2013 and the Rules made thereunder relating to electronic voting (which includes remote e-voting and e-voting conducted during the AGM) on the resolutions proposed in the Notice calling the AGM of the Company was the responsibility of the management. 3. The facility for e-voting during the AGM was provided by National Securities Depositories Limited. The e-voting period remained open from **Tuesday, 23rd September, 2025 at 09.00 A.M. (IST)** and ends on **Thursday, 25th September, 2025 at 05.00 P.M. (IST)**. 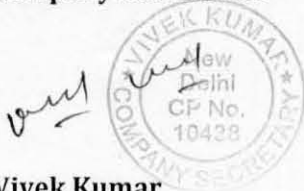
